ORDER

Provisional affiliation was granted for starting the B.Ed degree programme during the academic year 2004-05 with permission to start the class during 2005-06 with an intake of 100 students, at EMEA Training College, Kondotty, Malappuram, vide University Order read 1st.

2.Vide paper read as 2nd, the National Council for Teacher Education, Southern Regional Committee, Bangalore, permitted the College to conduct the B.Ed degree programme of two-year duration with an annual intake of 100 students with two basic units of 50 students each from the academic session 2015-16.

3. Vide University Order read as 3rd, orders were issued to grant Continuation of Provisional Affiliation to each batch of the Teacher Education Colleges, at the beginning of the course, keeping the existing formalities without insisting orders for extension of approval from NCTE in each year.

4. As per the University Order read as 4th, a revised permanent distribution of seats, w.e.f. the academic year 2020-21, were sanctioned at various Training Colleges in Malappuram District.

5.Continuation of provisional affiliation was granted to the B.Ed programme for the academic year 2025-26 conditionally, subject to the submission of the renewal NOC from the Government of Kerala, vide university order read as 5th.

6.The Principal, EMEA Training College, Kondotty has requested, vide paper read 6th, for Continuation of Provisional Affiliation to B.Ed programme for the academic year 2026- 27.

7.The Principal has submitted RNOC's of self financing B.Ed Degree programme for the academic years 2025-26 & 2026-27 vide Government orders read as 7th & 8th.

8.Considering the above, sanction is accorded by the Vice Chancellor

- to make the University Order read as 5th, by which continuation of Provisional Affiliation was granted conditionally to the self financing B.Ed programme for the academic year 2025-2026, as absolute.
- for granting Continuation of Provisional Affiliation to the Self Financing B.Ed programme (as detailed in the table below) at EMEA Training College, Kondotty, Malappuram, for the academic year 2026-27.

9.Orders are issued accordingly subject to the conditions specified hereunder:

- Affiliation granted is strictly provisional and only for the academic year 2026-27. The college must apply for CPA for the ensuing years by remitting the fee fixed by the University from time to time, along with the extension of approval orders, if any, from the apex bodies concerned.
- The institution must strictly adhere to the Supreme Court directions in (WP (C) 656/1998) regarding ragging prevention; failure to do so will lead to withdrawal of affiliation. Additionally, the college must comply with all conditions stipulated in the renewed NOC from the Government of Kerala for the 2026- 27 academic year.
- Admissions for the next academic year shall only be made after obtaining prior permission from the University. No student shall be admitted in anticipation of affiliation, and all selections must strictly follow University/Government rules and regulations.
- All colleges must comply with the relevant regulations & Syllabi. The Principal must ensure that only the syllabi approved by the University and available on the official website (www.uoc.ac.in) are followed.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2026-27.
- The courses sanctioned in this order shall not be used as a basis for calculating subject workload or for claiming additional teaching faculty. Separate competent orders must be obtained from the Government/University for such requirements.
- The conduct of University examinations (including CDOE Examinations) is compulsory and binding. Examinations are only permitted if the college has been granted continuation of

provisional affiliation or if their application is currently under process.

Violation of any of the above conditions will lead to the cancellation of affiliation.
